Player and Parent understand and agree to pay the total amount per player for team dues according to the team the player is assigned to.

- Parent and Player understand that there are no refunds of any fees paid once a player accepts a spot on a team for any reason. Such as injury, mental health, and family relocation, dismissal from program due to violation of Team policies, JVA Policies, USAV Policies, or AAU Volleyball Policies. NINEONE reserves the right to adjust as necessary.
- Parent and Player understand that fees paid to NINEONE VOLLEYBALL do not guarantee any particular amount of playing time, positions within a team lineup, leadership roles, or duties.
- Player and Parent understand that fees paid to participate in NINEONE VOLLEYBALL constitute a commitment to the team.
- Parent and Player understands that all team fees are to be paid using the web based payment system set forth at www.nineonevolleyball.com or by cash/check (made payable to NINEONE Volleyball). Parent and Player understand that any and all fees associated with NSF/Declined Credit or debit/Returned checks are the direct responsibility of the Parent and Player. Parent and Player authorize NINEONE VOLLEYBALL to invoice their account in the NINEONE VOLLEYBALL Online Payment System in the initial payment option.
- Player and Parent understand that all payments must be received by NINEONE VOLLEYBALL on the agreed upon date for the payment to be considered on time. Player and Parent understand there is a \$25 late fee for any and all fees collected after 15th of each month.
- *Please note that if paying via credit card, there is a service fee added to the total.*
- I understand that I can set up automatic payments and the credit card that I designate will be automatically charged on each date. It is my responsibility to ensure that a current credit or debit card is maintained on file until all club fees are paid.
- Furthermore, Parent and Player agree that NINEONE Volleyball Club is providing a service, rather than a product. By signing this Agreement, Parent and Player agree not to dispute or reverse any payments made by check, credit card, or debit card for services provided by NINEONE Volleyball.
